CONDITIONS OF MEMBERSHIP

- 1) Membership of the Club is conditional upon the observance of Club Rules. Members and their guests shall observe any regulations for the use of the facilities posted in the Club and which may be added to and varied from time to time.
- 2) The Membership subscription shall be fixed by the Proprietors and shall be payable annually advance or by standing order mandate. It is not refundable or transferrable.
- 3) Persons wishing to become Members of the Club shall complete the Application Form and submit this to the Proprietors.
- 4) Membership shall be renewed by payment to the Club of the annual subscription in force at that time and before the specified date on the invoice.
- 5) A Member is entitled to use the facilities of the Club providing always that the Club may at any time withdraw all or part of the facilities for any period or periods where the same are required for use by the Club, or its guests in connection with any repair, operation or maintenance work to the facilities or to the Club.
- 6) The Proprietors reserve the right to refuse admission and or/cancel membership forthwith if any Member shall in their opinion cause nuisance or annoyance to other Club Members or members of staff or to other users of the club facilities.
- 7) Members and guests must at all times conduct themselves in an orderly and polite manner.
- 8) Membership badges must be displayed at all times.
- 9) By their membership, Members accept and agree to be bound by the rules of the Club
- 10) Any Member or guest using the golf course or any of the Club facilities do so at their own risk.
